PIAC Co-chairs Report

June 19, 2018

PROGRAM & SCHOOL SERVICES COMMITTEE DEPUTATION MAY

No recommendations made by PIAC. PIAC co-chairs were unable to attend this meeting, but reports for the April and May PIAC meetings were presented to the committee.

STATUS OF PREVIOUS PIAC MOTIONS AND ACTION ITEMS

Fundraising Guide

Motion: After PIAC made a recommendation to PSSC in April, the Board decided at their May 23, 2018 meeting:

- (a) That school councils be consulted on the Board's 2017-18 Fundraising Resource Guide;
- (b) That consultations be done for any future updates to the Fundraising Guide and any related guidelines, in accordance with O. Reg. 612/00, s.19 (1.1.iv).

Update: Consultation will be done in the fall on both the fundraising policy and the fundraising guidelines. Staff are currently working on developing the revised policy and process for consultation. PIAC stressed that any changes to the policy or guidelines i.e. changes that are proposed before the revised fundraising policy consultations occur, still need to go through a consultation process before being implemented. Further, that any guidelines that are not included in the fundraising policy review consultation still need to go through a consultation process as per Reg. 612.

Board Website: Parent Tab

Motion: After PIAC made a recommendation to PSSC in April, the Board decided at their May 23, 2018 meeting:

- (a) That access to key parent resources be increased by adding a permanent tab named Parents to the landing page and headers on the Board's website, tdsb.on.ca:
- (b) That, as a body legislated to advise the Board on matters of parent engagement and communication, the Parent Involvement Advisory Committee be consulted on the creation of a tab for parents, as referenced at Part (a), and the navigations links selected for the drop down menu.

Update: Staff indicated that Ross Parry (TDSB Communications) will work with PIAC to

update the website. PIAC Communications working group will connect with Mr. Parry and report back on the progress of the parent tab.

Permits for School Councils

Motion: After PIAC made a recommendation to PSSC in April, the Board decided at their May 23, 2018 meeting that the following be referred to staff:

- (a) That school councils be granted access to school facilities during non-school and after-school hours for school related activities and meetings, provided:
 - (i) That all activities adhere to the mandate of the school council as outlined in Regulation 612/00;
 - (ii) That appropriate insurance for events outside of the Board's scope has been purchased;
 - (iii) That custodians are regularly scheduled or can be rescheduled to work;
- (b) That the policy P011, Community Use of Board Facilities (Permits) be amended to waive permit fees for school council related meeting and activities.

Update: Staff working on the revised Community Use of Schools Policy will incorporate feedback received from PIAC. Draft policy should come to the Governance & Policy Committee in the fall.

School Generated Funds Guidelines

Action Item: PIAC was presented with the revised (February 2017) School Generated Funds Guidelines at their March 21, 2017 meeting and provided feedback on the document. PIAC requested that the final draft of the guidelines be brought back to PIAC for feedback and was informed that the document would come back to us once our suggestions were incorporated. PIAC was also informed that the board is working on a process to finalize the procedure through consultations with school councils.

Update: The Board is presently preparing the fundraising policy for consultation in the fall. The policy is to include clear guidelines for School Generated funds. PIAC will be provided with the opportunity for consultation.

TDSB School Profile pages

Motion: that the 'parent' and 'school council' tabs of all TDSB school profile pages include a reference link to PIAC's website

Update: Planned update of all TDSB school web pages during the summer was not completed. Communications/Outreach working group will follow up with TDSB communications in the spring of 2018.

SAC Survey Snapshot Report

Update: Survey results have not yet gone to the Program and School Services Committee (PSSC) for discussion. PIAC's response document was included in the September report to PSSC. Co-chairs will follow up with PSSC when the survey comes to the committee.
