Overview

- Currently the TDSB has 21 Secondary Alternative Schools
- Secondary alternative schools are smaller school environments (small schools by design) supporting students seeking alternative methodologies, curriculum delivery, and non-mainstream approaches to learning the Ontario Curriculum
- This is not a review of elementary alternative schools



Secondary Program Review

- Board of Trustees approved action plan to review of all secondary schools, programs, policies, and procedures began in 2019.
- All secondary school students across the TDSB deserve equitable access to stronger programs and richer pathways, as close to home as possible. The system will need to be re-envisioned and re-drawn to support this goal.
- 1976 enrolment: 140,433 students
 - 2019 enrolment: 73,000 students
- Secondary Alternative Schools are part of the overall Secondary Program Review

Review will include:

- Policies and procedures
- Technical and commercial boundaries
- Access to specialized schools and programs
- Facilitated access to skilled trades (FAST)

Secondary Program Review

Guiding Principles

- Equity of Access
- Efficient and Flexible Learning Space
- Strong neighbourhood schools of a sufficient size to offer viable programs
- Provide program choice driven by student needs and interests

Final recommendations may include the following:

- School closure(s)
- Relocation or consolidation of existing program(s)
- Repurposing of secondary school buildings to address other system needs
- Different models of school organization, including full-year programming and campus models

Objective of Secondary Alternative Schools Program Review


May 26, 2021 Board motion was approved based on the recommendation from the Alternative Schools Community Advisory Committee:


That the Director conduct a separate review of all secondary alternative schools to determine:

- a. Their strengths, weaknesses, opportunities and threats as enrolment and staffing numbers continue to decline;
- b. What additional systems, processes and changes may be necessary to improve and better support secondary alternative schools and their students.

Program Review Action Plan

At the June 9, 2021 Program and School Services Committee meeting, staff reported that the review will include:

- Environmental scan of Secondary Alternative Schools, including demographics and history
- Analysis of strengths, weaknesses, opportunities and threats faced by students, staff and communities
- Involvement of multiple stakeholders (students, staff, parents/caregivers, and communities)

c) preliminary analysis of programs, strengths and growth areas, and staff and communities connected to Secondary Alternative Schools	
Provide a final report to Program and School Services Committee and the Board on System-wide recommendations and long-term visioning following completion of Secondary Alternative Schools review	Spring 2025
