Description/ Objective	<p><b>Description:</b> The Consultations Working Group was formed to prioritize, summarize, and disseminate information to PIAC, and where applicable the TDSB parent community, regarding Policies and Procedures under review by the TDSB. Dissemination of information will be coordinated with PIAC Ward Representatives and the Communications &amp; Outreach Working Group. Update	<p>The Working Group met twice since the April PIAC meeting:  <b>Tuesday, May 4<sup>th</sup> from 6 to 7 pm</b>  <b>Thursday, May 13<sup>th</sup> from 7 to 8 pm</b></p> <p><b>Summary of Tuesday, May 4, 2021:</b>  The update on previous business included the reply from Lorraine Linton that the Specialized Schools and Programs policy timeline is being reviewed. As of this report, no new timeline has been made public. New business included a request from Michelle Munroe for two participants for a review of school council bylaw templates and operational guidelines. Aretha Philips and Susan Lee volunteered with Felicia Seto-Lau as alternate. The bulk of the meeting was spent discussing a letter response to the Ministry of Education on the potential for permanent remote learning similar to the template the TDSB Trustees are circulating.</p> <p><b>Post meeting actions:</b> The volunteers’ names were forwarded to Michelle Munroe for the discussion on council documents. Ken Ng and Kate Leuschen Millar took the lead on drafting both a letter on behalf of PIAC and a letter to be circulated to parent/guardians on the potential for permanent remote learning. Another meeting was set after the PIAC Executive Meeting to review the draft in preparation for the PIAC general meeting.</p> <p><b>Summary of Thursday, May 12, 2021:</b>  The meeting was primarily to review and discuss the distribution of the two PIAC letters regarding the potential of permanent remote learning. Edits were documented by Kate Leuschen Millar and a final document was circulated to all Working Group members after the meeting. Changes were considered until Sunday, May 16 at which time the letters would be finalized for distribution to all PIAC members with the Working Group report. A motion was requested at the Executive Committee to adopt the PIAC letter [see below]. The template letter for parent and guardians would be a call to action [see below]. It was recommended that distribution include the Communications Working Group and the use of the PIAC website to facilitate the use of Google Translate for the parent/guardian community. The members also discussed whether using a platform like Change.org would assist in distribution of a letter. Kate Leuschen Millar will discuss this possibility with the Communications Working Group.</p> <p><b>Post Meeting Actions:</b> The two letters were finalized and links are provided below.</p>
