The minutes of each meeting shall include a notation of those members absent and those members advising of apologies for absence. Any member who misses either (a) three (3) or more consecutive PIAC general meetings without advising apologies for absence, or (b) a total of four (4) PIAC general meetings in any fiscal year, may be removed from his/her seat. PIAC Election Guidelines on election timelines – Clarification on the guidelines as it specifies elections should happen between October 1 and the first week of November, inclusive or within 60 days of the vacancy but not during school or statutory holidays PIAC will take responsibility and if election cannot be held within the specified time. → Membership WG will update PIAC Election Guidelines and bring updated version to the Fall 2021 PIAC meeting for approval 4.
