PIAC General Meeting Cancelled - March 26, 2024

The March 26^{th,} 2024, PIAC General meeting was cancelled due to the Finance Board Enrolment Committee (FBEC) meeting taking place on March 26, 2024, that will require the attendance of the PIAC Trustee representative. Regulation 330/10 (612/00) states (1) A parent involvement committee shall meet at least four times in each school year. O. Reg. 330/10, s. 6. (2). A meeting of a parent involvement committee cannot be held unless:

- (a) a majority of the members present at the meeting are parent members;
- (b) the director of education, or the person designated under subsection 46 (1), is present; and
- (c) the member of the board who sits on the committee, or the person designated under subsection 46 (2), is present. O. Reg. 330/10, s. 6.
