Early French Immersion Application Process

Please forward information to all of your schools. The entry point to Early French Immersion for September 2025/26 school year is Junior Kindergarten. The application to the Early French Immersion program will remain an online process managed by the TDSB's Central French Department, and applications must be completed online between November 4 and November 29, 2024. An offer of placement in the program (not a specific school) is guaranteed to all eligible on-time applicants.

Families with an older sibling currently in an Early French Immersion program at the same school are still required to complete an online application for the new student.
