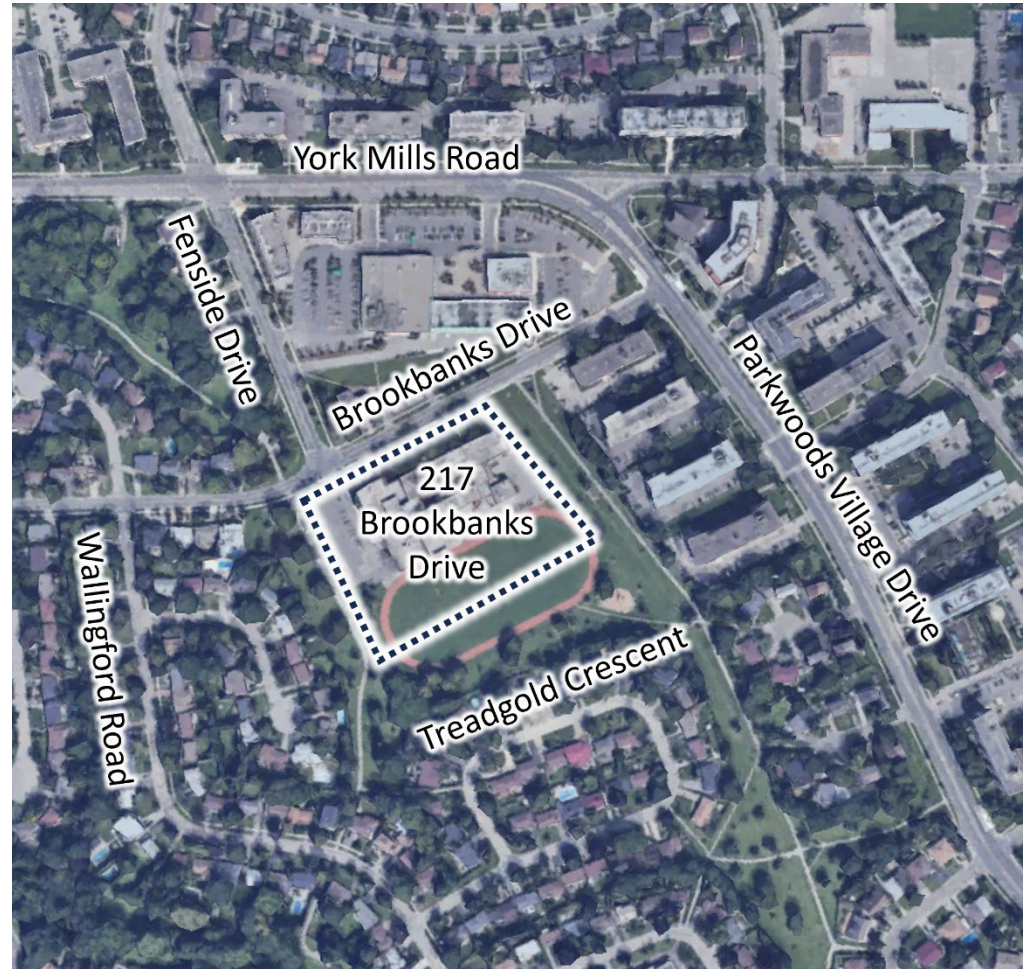
# Purpose of the Meeting

- The TDSB is reviewing the property it owns at 217 Brookbanks Drive.
- The TDSB wants to receive feedback from the community on the proposal to sell the 217 Brookbanks Drive property.
- Community feedback will be included in a staff report to the Board of Trustees regarding the sale of the property.



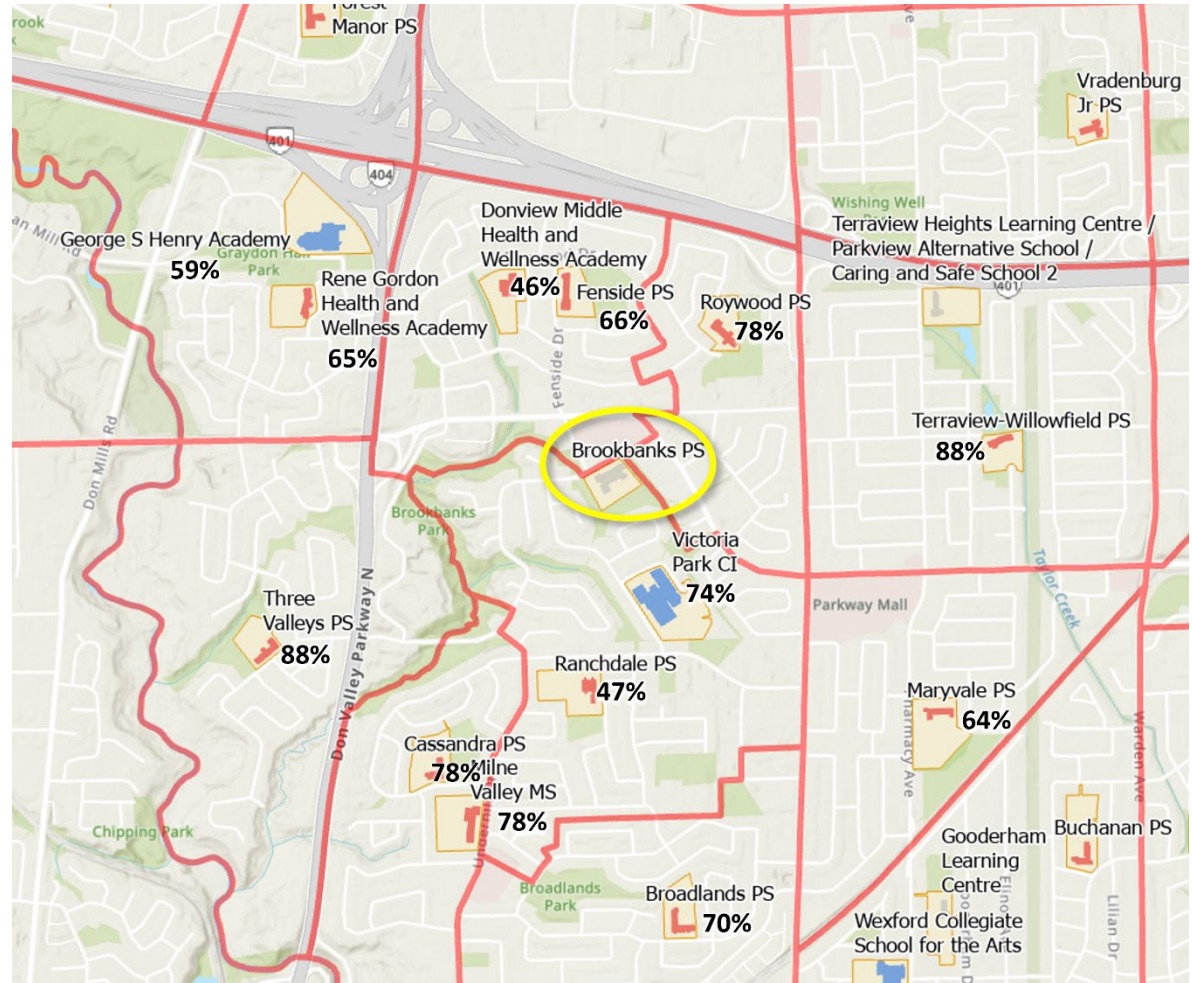
# Background

- Located southwest of Brookbanks Drive and Parkwoods Village Drive.
- 5.16 acres in area.
- Under a lease to Crestwood Preparatory College.
- Used as a private high school.
- The lease expires in August 2026.
- In the lease agreement, the tenant has the first right to purchase the property if it is offered for sale on the open market.



# Why is the property being considered for sale?

- The TDSB would like to generate revenue to invest back into its buildings to address the massive backlog in major repair.
- TDSB staff has determined that the 217 Brookbanks Drive building is not necessary for TDSB purposes:
  - There is a great distribution of TDSB elementary and secondary schools in the area;
  - Any future growth in enrolment will be accommodated on other school sites.
- The tenant at 217 Brookbanks Drive has expressed interest in purchasing the property.

# Provincial Sale Process

- In selling or leasing a property, the TLC must follow rules contained in *Ontario Regulation 374/23, Acquisition and Disposition of Real Property* (even if there is an interested buyer).
- Under *Ontario Regulation 374/23*, the TDSB and TLC must follow a two-step process to sell a property:
  - **Step 1** – Submit the property to the Province during a pre-determined intake window:
    - The Province then has 120 days to determine whether the property is required to meet the needs of another school board or to address another matter of provincial interest.
    - The Province will advise the school board after or during the 120-day period whether the site is required for one of these purposes.
  - **Step 2** – If directed, sell the property to another school board or provincial entity, or proceed to sell the property on the open market.
- *Ontario Regulation 374/23* requires a property to be sold at fair market value.



# Timelines

- **Today** – Community consultation – feedback received by Friday, November 22, 2024, will be included in TDSB staff report.
- **November 27, 2024** – TDSB staff report to the Finance, Budget and Enrolment Committee meeting.
- **December 11, 2024** – TDSB staff report to Board of Trustees meeting – final decision is made.
  - The property will be submitted to the Province at the next available intake period, upon which the 120-day review period will begin.
- **Spring 2025** – The Board will receive direction from the Province on the sale of the site. If a need is identified the sale could be to another school board or provincial entity.
- If the Province has not identified another need for the site, the TLC will work with Crestwood Preparatory College on the sale.

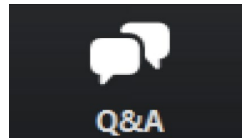

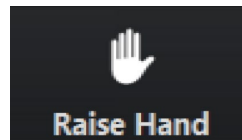

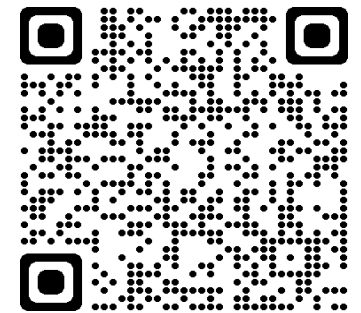
