



Setting the Context: Long-Term Program and Accommodation Strategy

- The LTPAS advances the system goal to "provide equity of access to learning opportunities for all students"
- The document identifies a number of studies to be undertaken to resolve existing and future accommodation pressures in the City
- Boundary Change Study: Explore a review of the shared attendance area that is assigned to both Humberside CI and York Memorial CI to determine a single designated secondary school






Setting the Context: Why are we here?

- TDSB's Long-Term Program and Accommodation Strategy (LTPAS) outlines several guiding principles
 - **Consistent attendance boundaries** -establish consistent attendance boundaries across the TDSB by reviewing instances of shared boundaries where multiple schools serve students based on home addresses and split attendance boundaries that separate graduating cohorts among multiple schools
- The purpose of this boundary change is to eliminate both the shared and split attendance areas at Humberside CI, Runnymede CI and York Memorial CI








Proposed Attendance Boundary Change

The proposed recommendations include:


- Directing the shared secondary attendance area between Humberside CI and York Memorial CI solely to York Memorial CI.
 - i. Designating the entire Harwood PS Regular Program intermediate attendance boundary to York Memorial CI
- Assigning the split George Syme CS intermediate attendance area, currently divided between Humberside CI and Runnymede CI, entirely to Runnymede CI for secondary school.



Proposed Attendance Boundary



Boundary Change Enrolment Projection – Humberside Cl




Humberside CI- Boundary Change Projected Enrolment

Humberside CI Outcomes:

- Decrease of approximately 2% utilization over time
- Approximately 16 20 secondary students would be designated to Runnymede CI and York Memorial CI
- Eliminates shared attendance boundaries for consistent secondary attendance boundaries

Boundary Change Enrolment Projection – Runnymede Cl




Runnymede CI- Boundary Change Projected Enrolment

Runnymede CI Outcomes:

- Slight increase in utilization to 88% in the long term
- Approximately 8-10 secondary students would be designated to Runnymede CI
- Eliminates split George Syme CS boundary keeping graduating cohorts together

Boundary Change Enrolment Projection – York Memorial Cl



York Memorial CI- Boundary Change Projected Enrolment

York Memorial CI Outcomes:

- Slight increase in utilization to 101% in the long term
- Approximately 8-10 secondary students would be designated to York Memorial CI
- Eliminates shared attendance boundaries for consistent secondary attendance boundaries



Staff Proposed Recommendations Attendance Boundary Change

 a) That the shared secondary attendance area between Humberside Collegiate Institute and York Memorial Collegiate Institute be directed entirely to York Memorial Collegiate Institute, effective September 1, 2026 (Regular Program)



Staff Proposed Recommendations Attendance Boundary Change

b) That the portion of the Humberside Collegiate Institute boundary that is north of the railway, and west of Keele Street (aligns with the George Syme Community School attendance boundary) be directed entirely to Runnymede Collegiate Institute, effective September 1, 2026 (Regular Program)



Staff Proposed Recommendations Legacy Students

c) That all students who reside in the portion of the Humberside Collegiate Institute attendance area described in recommendation a) and b) above and attend Humberside Collegiate Institute as of June 30, 2026, may choose to remain at Humberside Collegiate Institute until they graduate



Staff Proposed Recommendations Legacy Students

d) That siblings of students described in recommendation
 c) be allowed to attend Humberside Collegiate Institute
 provided their older sibling is attending Humberside
 Collegiate Institute at the time that they enter the
 school, and be allowed to remain until they graduate



Staff Proposed Implementation Plan September 2025 *No change*

- **Current Humberside CI students** are allowed to remain at Humberside CI until they graduate
- Current Harwood PS Grade 8 students within the shared attendance boundary starting secondary school may choose to attend either Humberside CI or York Memorial CI until they graduate
- Current George Syme CS Grade 8 students within the split attendance boundary (designated to Humberside CI) starting secondary school may attend Humberside CI until they graduate

Staff Proposed Implementation Plan September 2026 *Change*

- New Regular Program students (without siblings attending Humberside CI) residing within the <u>Humberside CI/ York</u> <u>Memorial CI shared</u> attendance boundary to attend <u>York</u> <u>Memorial CI for Grades 9-12</u>
- New Regular Program students (without siblings attending Humberside CI) residing within the <u>George Syme CS split</u> *intermediate* attendance boundary to attend <u>Runnymede CI</u> for Grades 9-12

Frequently Asked Questions

When will the attendance boundary changes take effect?

If approved, the changes to the attendance area boundaries are set to take effect in <u>September 2026</u> for new Regular Program students residing at the specified addresses.

Will the attendance boundary changes effect the secondary school pathway for French?

There are currently <u>no changes</u> being proposed to the secondary school pathway for French Immersion program students who reside or move to the area.



Frequently Asked Questions

Will my address be affected by this boundary change review?

Yes, if you live within the shared secondary attendance area of Humberside CI/York Memorial CI or if you live within the portion of George Syme CS' intermediate attendance area that is currently designated to Humberside CI.


The boundary change <u>effects new Regular program students</u> looking to register at Humberside CI in September 2026, provided they <u>do not have an older sibling attending the school.</u>


